# Motions to disallow delegated legislation defeated

The Senate **did not agree** to motions which would have disallowed the following regulations:

- □ Criminal Code Amendment Regulations 2005 (No. 14), as contained in Select Legislative Instrument 2005 No. 298, specifying the Kurdistan Workers Party (PKK) as a terrorist organisation, and made under the Criminal Code Act 1995—moved by Senator Bob Brown [first speaker see also debate on the motion on 16 August 2006]
- □ Telecommunications (Operational Separation Designated Services)

  Determination (No. 1) 2005, made under subclause 50A(1) of Schedule 1 to the Telecommunications Act 1997 *and* Telecommunications (Requirements for Operational Separation Plan) Determination (No. 1) 2005, made under paragraph 51(1)(d) of Schedule 1 to the Telecommunications Act 1997–moved by Senator Conroy [first speaker]

# Notice was given of motions to disallow the following

<u>Senator Milne asked</u> the Minister for the Environment and Heritage for an explanation of an answer not being provided to a question on notice relating to solar energy. <u>The Minister</u> provided an explanation.

# Orders for the production of documents

## Motion defeated

A motion moved by Senator Wortley requiring the Minister for Immigration and Multicultural Affairs to table a report by the Department of Immigration on the employment of workers on subclass 457 visas was defeated

# Notice of motion given

Senator Stott Despoja gave a <u>notice of motion</u> to require the Minister representing the Minister for Health and Ageing to table the report prepared for the Government by Matthew Pegg Consulting Pty Ltd on developments in assisted reproductive technology by 5 September 2006

# Orders with continuing effect

## Indexed lists of departmental and agency files published on the internet

A statement of compliance for the Communications, Information Technology and the Arts portfolio agencies was tabled [Letters of advice about certain files created by departments and agencies are required to be tabled twice a year]

## Unproclaimed legislation

A document was tabled showing details of unproclaimed Acts, together with a statement of reasons for non-proclamation and a timetable for their operation [Standing order 139(2) requires tabling before 31 August each year]
