#### 1 MEETING OF SENATE

The Senate met at 12.30 pm. The President (Senator the Honourable Paul Calvert) took the chair and read prayers.

# **3** CONSIDERATION OF LEGISLATION

The Minister for Justice and Customs (Senator Ellison), at the request of the Minister for the Arts and Sport (Senator Kemp) and pursuant to notice, moved government business notice of motion no. 1—That the provisions of paragraphs (5) to (8) of standing order 111 not apply to the Customs Amendment (Extension of Import Cut-over Time) Bill 2005, allowing it to be considered during this period of sittings.

Debate ensued.

Question put and passed.

#### 4 PARLIAMENTARY ZONE—CAPITAL WORKS PROPOSAL—APPROVAL

The Minister for Justice and Customs (Senator Ellison), at the request of the Minister for Communications, Information Technology and the Arts (Senator Coonan) and pursuant to notice, moved government business notice of motion no. 2—That, in accordance with section 5 of the *Parliament Act 1974*, the Senate approves the proposal by the National Capital Authority for capital works within the Parliamentary Zone, being the construction of a pathway on the southern foreshore of Lake Burley Griffin, including Australian of the Year Walk.

Question put and passed.

#### 5 SKILLING AUSTRALIA'S WORKFORCE BILL 2005 SKILLING AUSTRALIA'S WORKFORCE (REPEAL AND TRANSITIONAL PROVISIONS) BILL 2005

Order of the day read for the adjourned debate on the motion of the Minister for the Environment and Heritage (Senator Ian Campbell)—That these bills be now read a second time—*and on the amendment moved by Senator Nettle in respect of the Skilling Australia's Workforce Bill 2005*—

At the end of the motion, add "but the Senate:

(a) condemns the Government for introducing legislation that would undermine the quality of public provision of vocational education and training by:

- (i) failing to recognise and reward the good will of Australia's Technical and Further Education (TAFE) teachers and support staff and their commitment to the best interests of their students and the community,
- (ii) attempting to introduce a climate of fear and greed into TAFE colleges, based on both punitive industrial relations arrangements and the entirely impractical requirement for performance-based pay,
- (iii) compromising the ability of TAFE teachers to work collaboratively by attempting to set them in competition with each other,
- (iv) using TAFE as a beachhead in their assault on Australia's union movement,
- (v) using TAFE as a pawn in their attempt to centralise decision making in Canberra and undermine the balance of power between the states and the Commonwealth,
- (vi) substituting financial blackmail of the states for proper negotiation with all interested parties and consensus building,
- (vii) playing out an agenda of revenge against the Australian Education Union and the New South Wales Teachers Federation for their well-founded criticisms of the Howard Government's failure to adequately fund public provision of vocational education and training, and
- (viii) further progressing their vision of a privatised vocational education and training sector, despite the massive failure of existing funding of private providers to effectively contribute to quality outcomes; and
- (b) calls on the Government to withdraw this bill because it is fundamentally flawed and will fail to address Australia's growing skills shortage, and instead to:
  - (i) develop arrangements for negotiation between the states, the Commonwealth and TAFE teachers and their union on funding of vocational education and training and on the coordination of policy setting in this sector,
  - (ii) recognise the current and potential future role that TAFE colleges and TAFE teachers and support staff play in wealth creation and in building Australia's cultural, social and democratic institutions,
  - (iii) recognise that the Commonwealth Government should play a key role in the funding of public provision of vocational education and training by restoring its per student funding of TAFE to 1996 levels in real terms and providing funding increases to match the growth in demand for vocational education and training over that period and for the next planning period, and
  - (iv) end the funding of private providers that compete with TAFE".

Debate resumed.

Debate adjourned till the next day of sitting, Senator Marshall in continuation.

On the motion of the Parliamentary Secretary to the Minister for Agriculture, Fisheries and Forestry (Senator Colbeck) the resumption of the debate was made an order of the day for a later hour.

Senator Milne moved—That the Senate take note of the answer given by the Minister for the Environment and Heritage (Senator Ian Campbell) to a question without notice asked by Senator Milne today relating to the natural heritage trust fund.

Question put and passed.

The Leader of The Nationals in the Senate (Senator Boswell), by leave, made a statement relating to comments he made during the discussion of matters of public interest on 10 August 2005.

- (b) congratulates the finalists of the 2005 Australian Museum Eureka Prizes for their perseverance and commitment to helping the community through their critical discoveries and innovative designs. (general business notice of motion no. 214)

- (a) notes that:
  - (i) 26 August 2005 marks the 4th anniversary of the rescue of 433 asylum seekers by the MV *Tampa*,
  - (ii) this rescue was followed by the refusal of the Government to allow the ship to enter Australian waters,
  - (iii) the asylum seekers did not have access to adequate medical care, legal advice or sanitary conditions, particularly for the pregnant women and children who were on board,
  - (iv) the MV *Tampa* was boarded by Australian Special Air Services troops and the asylum seekers taken to Nauru,
  - (v) the unnecessary and degrading cost of the resulting Pacific Solution is estimated at close to a billion dollars, which does not take into consideration the cost of human suffering, and
  - (vi) some of the refugees rescued by the MV *Tampa* are still on temporary protection visas and have therefore not been able to reunite with their families after more than 4 years apart;
- (b) expresses the view that many of the changes made to the *Migration Act 1958* following the MV *Tampa* incident have undermined basic legal principles such as equality before the law, procedural fairness, transparent accountability of the actions of Commonwealth officers and protecting against refoulement; and
- (c) calls for review and reform of the Act, and an end to the Pacific Solution, mandatory detention and temporary protection visas. (general business notice of motion no. 219)
- Senator Milne: To move on the next day of sitting-That the Senate-
  - (a) notes:
    - (i) the loss of independence in the assessment of Australian heritage sites since the Australian Heritage Commission was absorbed into the Department of the Environment and Heritage,

- (ii) the failure of the Government to protect Australian heritage sites since that time, including Recherche Bay in Tasmania and the Burrup Peninsula in Western Australia, and
- (iii) the Government's willingness to manipulate the heritage assessment and funding process for political purposes; and
- (b) calls on the Government to re-establish an independent statutory heritage body with authority to assess sites and allocate funding for heritage protection. (*general business notice of motion no. 220*)

- (a) acknowledges research by the Centre for Genetics Education on attitudes to predictive genetic testing as a part of the Australian National University's Australian Survey of Social Attitudes;

- (c) notes that the Government has not yet released its response to the Australian Law Reform Commission (ALRC) report no. 96, *Essentially yours: The protection of human genetic information in Australia*; and
- (d) calls on the Government to respond to the ALRC's report and implement federal laws to protect our genetic privacy and prevent discrimination. (*general business notice of motion no. 221*)
