Dear Mr Walker,

I refer to your letter of 12 August 2005, in regard to the extension of mobile polling at Trinity Village.

I apologise for the delay in responding to your letter of 1 April 2005. I commenced 3 months leave on 4 April, the day on which your letter was received in this office. I believe that the staff here assumed that the matter was being investigated.

The matter has been under consideration by the AEC's Central Office in Canberra. The process for legislative changes to the provisions of the Commonwealth Electoral Act (CEA) involves the public invitation to stakeholders to make submissions to the parliamentary Joint Standing Committee into Electoral Matters (ISCEM). After its deliberations, the JSCEM reports to the Government with recommendations. The report into the conduct of the 2004 Federal Election is expected towards the end of this year. If the JSCEM recommends that mobile polling provisions be extended and the Government accepts that recommendation, the Government would then draft legislation in the Parliament to amend the CEA. Under normal circumstances, amendments are usually effected in time for the next Federal Election (due in 2007).

While I agree that it would be preferable that both the AEC and WAEC had a similar approach to mobile polling, until such time as the Government determines its position on the matter, the AEC is bound by the existing legislation. If not already considered, contact could be made with Dr Mal Washer, the MHR for Moore.
