I have working in various roles with the IT industry for over 20 years and can cite examples of overpricing for Australia from the following companies:

Microsoft

Adobe

VMware

Nero

And today Logitech

Some of these I have documentation of the correspondence I have had with them.

However today from one of my newsfeeds I was notified of new products announced by Logitech.

Principally they deal with sound devices - earphones and such.

The pricing differences between their various sites across the world supports the contention that we pay too much in Australia, and in my view is price gouging.

The product I will use as an example is the Logitech Ultimate Ears 900 (Logitech UE 900).

[I have been following pricing on these as I have had difficulty sourcing replacement parts in Australia from them .]





Based on these figures I should purchase the item in the USA and cover any currency/exchange rate dealings within my credit card. However, on previous investigations this company uses geo-location within their website to bar transactions out of the nominated locations.

I feel that Australians are being extremely disadvantaged by this market manipulation.

Despite our small market our proximity to the manufacturers presumably in Asia we are paying the highest price of any location. I can t see them being manufactured anywhere else, despite the company appearing to be headquartered in Switzerland.
