2. Has the Adelaide to Darwin rail fulfilled its ambitions as being the second outlet for South Australia in terms of Asian shipping? (p. 12)

Since the completion of the Adelaide to Darwin rail line in October 2003, there have been increases in the volume of exports in products that exit through Darwin yet originate in South Australia. In 2002/03, the freight volume was 1,351 tonnes and, by 2006/07, the volume had increased to 5,131 tonnes. The export volume peaked at 8,891 tonnes in 2004/05.

FreightLink, the freight rail operator, predicts further increases in the Adelaide to Darwin freight task. These increases are likely to come from general freight and also new developments and expansions in South Australia's mining sector.

GREEN TRIANGLE COMMON STATEMENT

A Green Triangle Freight Summit was convened by the Victorian and South Australian Governments on 9 May 2008 in Portland and Mt. Gambier.

Purpose

The purpose of the Summit was to enable the Victorian Minister for Roads and Ports, Tim Pallas, and the South Australian Minister for Transport, Patrick Conlon, to be briefed by industry and local government representatives on the impact on the regional transport network of the harvesting of timber plantations in the Green Triangle from 2009 onwards.

The timber freight task needs to be managed in the context of the total freight task in the Green Triangle region, taking account of existing and forecast growth volumes in mineral sands, grain, livestock and other bulk products.

Presentations

Presentations were made by:

- Timber companies;
- Port of Portland;
- South Australian Freight Logistics Council;
- Victorian Freight and Logistics Council;
- South Australian Road Transport Association;
- Glenelg Shire Council; and
- South East Local Government Association.

Outcomes of the Summit

Actions that Ministers decided would be undertaken arising from the Summit were:

- Development of a Freight Action Plan for the region, with a draft to be completed by State and local government officials by December 2008;
- Establishment of a Cross-Border Regulatory Efficiencies Taskforce to identify regulatory barriers to the efficient and seamless movement of freight between the two States;
- The Freight Summit would continue to be convened on an ongoing basis twice-yearly; and
- Joint advocacy should be undertaken by Government and industry to the Commonwealth Government to highlight the strategic value to national supply chain efficiency of addressing constraints in the Green Triangle transport network.

The following conclusions emerged from the Summit discussion.

- The Action Plan should draw on extensive regional transport planning work already completed in both States, including by local government and port authorities.
- The Plan should not replicate this but instead update and bring it together.
- An important role for State Governments is coordination and leadership.
- High Productivity Freight Vehicles (HPFVs) have a vital role to play in moving large volumes of wood chips efficiently and with reduced impacts on communities and amenity. This requires upgrades to infrastructure and regulatory approvals within the Performance Based Standards (PBS) framework.
- It is very important to manage social, environmental and urban amenity issues. We must bring communities with us. Research shows communities are willing to support the deployment of larger and/or higher productivity freight vehicles if it means fewer truck movements in their towns and cities.
- Land use planning should protect both urban amenity and critical freight corridors with appropriate reservations and buffers.
