Topic: Complaints in Townsville rollout

Senator Macdonald asked:

What was the level of complaints from residents about the rollout in Townsville?

Answer:

Of the 133 construction complaints received in the five mainland first release sites, Townsville accounted for only 20.

Context

Mr Quigley

...We also have work going on, as you know, in five mainland sites around Australia. They are in Armidale, Willunga, Brunswick, Townsville and Kiama. I will not go through all of the statistics on that, other than to say I think you did ask about complaints in any of those areas. We did in fact obviously have some complaints as we were doing the rollout in those places, mostly related to the physical aspects of the build. The total number of construction complaints we had was 133, which represents a complaint level of one per cent of the premises covered in those first release sites. In each of those complaints, we address them and we make sure they are resolved to the satisfaction of the complainants; we have a process in place to try to do that to the best of our ability.

Senator IAN MACDONALD: I am sure Telecom or the Postmaster-General had the same thing, but without competition they did not put it into effect. Anyhow, that is a comment. Were the complaints of one per cent even across Australia or were there more in one particular area?

Mr Quigley: No, if I look at the numbers, my recollection is that there were more in Kiama than in other places. **Senator IAN MACDONALD:** Being parochial, can I ask you on notice what the Townsville situation was. **Mr Quigley:** Yes.

Topic: Incremental cost of extending fibre to Julia Creek

Senator Macdonald asked:

Can you give me some indication of the incremental cost of providing fibre to Julia Creek?

Answer:

NBN Co Network Planning & Design are undertaking a study of Julia Creek to identify the incremental cost per premises to provide fibre to the town compared to what it would have cost if the town was covered by the planning rule of 500+ premises on an existing transmission route.

In order to complete the study data on the existing infrastructure (for example the Telstra Exchange to accommodate the Fibre Access Node) the costs for construction at this location have to be obtained. It is estimated that the case study will be completed by late July 2011.

Topic: Percentage of homes connected using overhead cable?

Mr Fletcher asked:

What percentage of homes will be connected using overhead cable and approximately how many thousands of kilometres of overhead cable do you expect in the access network?

Answer:

The percentage of premises assumed to be passed by overhead cable within the access network is 25 per cent over the full deployment period (forecast to be 9.5 years to December 2020 in the Corporate Plan).

This would represent an estimate of close to 50,000 kilometres of overhead cable sheath deployed across the fibre footprint.

This assumption in the Corporate Plan is dependent on the availability of existing underground infrastructure, which is anticipated to be sourced from Telstra, as well as the premises density (distances between premises) in the areas where Telstra ducts would not be available.

Topic: Use of overhead cable in Bradfield electorate

Mr Fletcher asked:

What is the risk of further overhead cable being installed in the electorate of Bradfield?

Answer:

An actual detailed design of the Bradfield electorate would be required in order to generate the appropriate knowledge of the fibre infrastructure requirements.

That said, NBN Co is committed to underground fibre infrastructure wherever suitable underground ducting is available.
