JOINT STANDING COMMITTEE
ON TREATIES. RE: TREATY
BETWEEN AUSTRALIA & JAPAN.
AVOIDANCE ON TAXATION.
DEAR SIRS.

IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY NOT BE RATIFIED. IT IS OUR POLICY THAT MULTINATIONALS OR OTHER NATIONS NOT BE ABLE TO AVOID TAXATION, WE CALL ON THE PARLIAMENT TO INTRODUCE A ONE PER CENT DEBIT TAX ON ALL FINANCIAL TRANSACTIONS. A ONE PER CENT DEBIT TAX WOULD RAISE \$ 360 BILLION DOLLARS MORE THAN CURRENTLY RAISED. IT WOULD ENSURE THAT EVERY PERSON WOULD PAY TAX, RICH OR POOR ALL OTHER TAXES COULD BE ABOLISHED. THE TREASURY COULD COLLECT THE TAX, THE AUSTRALIAN TAX OFFICE ABOLISHED, SAVING MORE MONEY. THE BANKS TO BECOME UNDER THE CONTROL OF TREASURY , REMOVING THE FEDERAL RESERVE BANK AS A PRIVATE COMPANY.
