# Amendment will enable the sale of cheaper drugs to developing countries

A proposed amendment to the World Trade Organization Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPS) will make it easier for developing countries to obtain cheaper versions of patented medicines needed to address public health problems. The TRIPS Agreement is one of the WTO agreements constituting the integrated WTO system of trade rules.

In addition to government representatives, the Committee will also hear from Dr Matthew Rimmer from the Australian National University who questions the effectiveness of the proposed amendment. He argues that the same amendment, agreed to as an interim measure in 2003 by the WTO, has so far not resulted in greater access to important drugs.

The public hearing will be held in **Committee Room 2R1**, **Parliament House**, **Canberra** on **Friday 22 June 2007** from **9.00** am.
