Final hearing for controversial ACTA treaty

The final public hearing on the controversial Anti-Counterfeiting Trade Agreement (ACTA) will be held in Canberra on Monday, 7 May.

The ACTA is designed to create robust Intellectual Property (IP) enforcement standards aimed at reducing the international trade in goods infringing IP, such as counterfeit trademarks and pirated copyright products.

Treaties committee chair, Mr Kelvin Thomson MP, said the third and final public hearing is being conducted so that the committee can gather as many perspectives on the treaty as possible, given it has inspired such a robust critical debate.

"The committee understands that this is a controversial treaty nationally and internationally and is interested in hearing all points of view", Mr Thomson said.

The Committee will also review a number of other treaties that were tabled in the Parliament on 7 February and 28 February 2012.
