

JOINT STANDING COMMITTEE
ON TREATIES. RE: TREATY

BETWEEN AUST. & GUERNSEY

RELATING TO TAX MATTERS.

DEAR SIRS.

IT IS THE SUBMISSION OF THE EXECUTIVE THAT THESE TWO TREATIES WITH GUERNSEY NOT BE RATIFIED, AS STATED IN PREVIOUS SUBMISSIONS THE ATO IS NOT A LEGAL ENTITY AND AS SUCH CANNOT BE PARTY TO AN INTERNATIONAL AGREEMENT, ALL TAXATION SHOULD BE HANDLED BY TREASURY, WE SUPPORT A LOW TAX SCALE OF ONE PER CENT AS A TRANSACTION TAX. WE DO NOT SUPPORT MULTINATIONALS AVOIDING PAYING TAX ON PROFITS, OR FOREIGN AID, FOREIGN DEBT PAYMENTS. WE CANNOT SUPPORT ANY TAX TREATY WHILE THOSE WHO AVOID TAXATION AS CORPORATIONS SNEER AT AUSTRALIA AND ITS GOVERNMENT (THE PEOPLE). WE CALL ON THE PARLIAMENT TO ABOLISH THE TAX OFFICE ( ATO ) AND STOP SENDING TAX PAYERS MONEY ABROAD. MONIES RAISED IN AUSTRALIA ARE TO PROVIDE GOOD GOVERNMENT, OR IT SHOULD BE, GOVERNMENT IS THE PEOPLE ACCORDING TO THE AUSTRALIAN CONSTITUTION, SOVEREIGNTY REMAINS WITH THE PEOPLE. PUBLIC MONIES SHOULD NOT BE SENT OVERSEAS WITHOUT A FORM OF REFERENDUM, WE CALL ON PARLIAMENT TO HOLD SUCH A REFERENDUM ON TAX MONIES LEAVING AUSTRALIA, A FUTURE PATRIOT LED PARLIAMENT WILL SCRAP ALL TAX AGREEMENTS AND MONEY FROM AUSTRALIA BEING SENT OVERSEAS, AUSTRALIANS DESERVE BETTER FROM OUR ELECTED OFFICALS, WE WISH TO THANK THE COMMITTEE FOR ALLOWING US TO COMMENT.
