ANY PERSON WHO DOES NOT WISH LIVE HERE SHOULD NOT EXPECT ANY
BENEFITS FROM AUSTRALIA. FURTHER MORE IT IS OUR POLICY THAT ANY
PERSON LIVING OUTSIDE OF AUSTRALIA BE STRIPPED OF CITIZENSHIP AS
AN AUSTRALIAN, IF THEY ARE NOT EMPLOYED BY THE AUSTRALIAN
GOVERNMENT. OUR POLICY MAY SEEM SEVERE BUT WE BELIEVE THAT
BEING AN AUSTRALIAN SHOULD NOT BE TAKEN FOR GRANTED. THE COSTS
BEING OVER \$1,900 M, FOR THE JAPANESE TREATY AND \$1,66 MILLION
FOR THE HELLENIC TREATY ARE FAR TOO MUCH, 2007 - 11, THESE TREATIES
ARE ONLY TWO TREATIES OUT OF MANY THAT ARE IN PLACE. IT IS TIME
WE STOPPED PEOPLE LIVING OFF AUSTRALIAN TAXPAYERS. WE CALL ON
THE PARLIAMENT NOT TO RATIFY THESE TREATIES ON SOCIAL SECURITY.
