EXTRADITION IS OF CONCERN TO THIS EXECUTIVE AS WE BELIEVE THAT PEOPLE WHO BREAK ANTI DRUG LAWS, SHOULD BE DEALT WITH , IN A FEDERAL COURT IN AUSTRALIA , ANY CRIME THAT IS COMMITTED AGAINST INTERNATIONAL CONVENTIONS SHOULD BE TRIED UNDER INTERNATIONAL LAW , AND BE SENT A FEDERAL PRISON HERE IN AUSTRALIA , ANY FOREIGN NATIONAL WHO COMMITS A CRIME OF TRAFFICKING, DRUGS, HUMANS, GUNS, SHOULD COURTS IN THEIR COUNTRY OF ORIGIN.

ONLY IN THE CASE OF OFFENCES SUCH TERRORISM SHOULD PEOPLE BE DEALT WITH HERE IN AUSTRALIA, CAPITAL PUNISHMENT SHOULD BE INTRDUCED TO DEAL WITH ANY FEDERAL OFFENCE, SUCH AS TERRORISM, OR SPYING FOR A NATION OF INTEREST, TO OUR SECURITY FORCES.
