# AGREEMENT ON BILATERAL COOPERATION BETWEEN THE GOVERNMENT OF AUSTRALIA AND THE GOVERNMENT OF THE KINGDOM OF THAILAND

The Government of Australia and the Government of the Kingdom of Thailand (hereinafter referred to as the "Parties")

<u>Inspired</u> by the traditional links of friendship, the warm and cooperative relations which exist between the two Parties, and their shared values, common regional interests and ties:

<u>Wishing</u> to give expressions to their mutual recognition as democratic, dynamic and outward-looking members of the region and the international community;

<u>Noting</u> the long-standing political, economic, social and security cooperation which has been reinforced between the Parties with respect to regional issues and their common interests in the stability, progress and prosperity of the Asia-Pacific region;

<u>Desiring</u> to cooperate with each other in accordance with principles embodied in international organisations, including the United Nations and the World Trade Organisation;

<u>Recognising</u> the Thailand-Australia Free Trade Agreement (TAFTA) between the Parties, and recognising further the broad range of Agreements and other arrangements which have been concluded and remain in force or effect between the Parties (as set out in Annex 1);

<u>Reiterating</u> the aspiration to establish a concrete framework for closer and broader cooperation in non-trade areas;

<u>Recognising</u> that broader and more diversified links between relevant agencies and organisations of the two countries would be of mutual benefit;

<u>Resolving</u> to undertake new and sustained efforts to strengthen, expand and diversify political, economic, social and security cooperation to the mutual benefit of the two Parties;

<u>Recognising</u> that deepening and expanding cooperation between the two countries transcends the scope and provisions of the existing Agreement on Economic Cooperation;

Have agreed to enter into the Agreement on Bilateral Cooperation between the Government of the Kingdom of Thailand and the Government of Australia (hereinafter referred to as "the Agreement") as follows:

#### **ARTICLE I**

# **OBJECTIVES**

The main objectives of the Agreement are:

- (a) to provide a framework for deepening and expanding bilateral cooperation and exchanges between the Parties, particularly in areas not covered by the Thailand-Australia Free Trade Agreement such as political, security, economic, social, educational, cultural and technical cooperation;
- (b) to intensify cooperation and consultation, in areas of mutual interest and concern;
- (c) to establish a bilateral consultative mechanism with a view to encouraging constant dialogue, exchanges and implementation of cooperative activities, as well as consolidating linkages pursuant to this Agreement.

#### **ARTICLE II**

#### **COOPERATION**

In the furtherance of the objectives set out in Article I of this Agreement, the Parties shall endeavour to:

- (a) exchange information in areas that have an impact on bilateral relations between the Parties;
- (b) intensify existing dialogues at all levels and constantly review the relevant areas of cooperation with respect to the existing bilateral arrangements and Agreements;
- (c) identify new initiatives and other potential areas of mutual interests such as capacity-building programmes, exchange of personnel and technology transfer;
- (d) promote linkages between national government agencies and encourage the implementation of specific projects for the joint cooperation between the Parties:
- (e) promote private sector participation in relevant areas of cooperation;

#### **ARTICLE III**

# SECTORS OF BILATERAL COOPERATION

The principal areas of cooperation shall include:

- (a) political and security issues, including defence and law enforcement (see Article IV);
- (b) economic, investment, and technical areas that are not covered by the Thailand-Australia Free Trade Agreement;
- (c) environment and natural and cultural heritage;
- (d) science and technology and energy;
- (e) information technology and telecommunications;
- (f) civil aviation:
- (g) public administration and public sector reform;
- (h) immigration;
- (i) education, culture, social development and tourism;
- (j) natural resource management in agriculture;
- (k) other areas as mutually agreed upon by the Parties.

#### ARTICLE IV

#### SECURITY AND LAW ENFORCEMENT

- 1. The Parties, building on the established bilateral security dialogue and long-standing defence and law enforcement cooperation, agree to consult on a regular basis to cooperate further on matters affecting their common security, including:
  - (a) issues which affect international peace and security;
  - (b) cooperation to combat threats to international security such as terrorism;
- (c) the proliferation of weapons of mass destruction (WMD) and their delivery systems;
  - (d) arms control and disarmament;
  - (e) mutual assistance in the effective implementation of export controls;
- (f) cooperation in the fight against transnational and organised crime, including economic and cyber crime, and the illicit trade in narcotic drugs, precursor chemicals and psychotropic substances;
- (g) Illegal immigration, human trafficking, smuggling of migrants and transnational sexual exploitation;
  - (h) mutual legal assistance in criminal matters and extradition;
  - (i) emerging issues which may threaten the stability of the region.
- 2. This cooperation shall include, where appropriate, exchanges, combined projects, intelligence sharing, military and law enforcement training, logistic support and defence material cooperation and joint exercises as would be mutually determined from time to time.

#### **ARTICLE V**

# **CONSULAR RELATIONS**

The Parties shall also cooperate in the following areas of consular relations:

- (a) the protection of the rights and interests of nationals of each Party in accordance with the Vienna Convention on Consular Relations;
- (b) the earliest possible notification of, and consular access to, detained and/or arrested nationals of each Party;
  - (c) the maintenance of close cooperation under the prisoner transfer scheme.

#### **ARTICLE VI**

# **INSTITUTIONS**

1. Effective implementation of this Agreement shall require close coordination and consultation between the two Parties. As a result, the Parties agree to establish a Joint

Commission on Bilateral Cooperation. The Joint Commission shall meet at the Ministerial level, including but not limited to, the Foreign Ministers of the two Parties at least every two years, or as otherwise agreed upon between the Parties, to review the overall cooperation and activities under this Agreement.

- 2. The Joint Commission shall establish committees or working groups as may be necessary to ensure proper implementation of the new Agreement.
- 3. The Joint Commission shall take into account the outcomes of the annual Thailand-Australia Senior Officials' Talks and other relevant meetings to review the progress made in the areas of cooperation as envisaged under this Agreement.
- 4. The Joint Commission shall also seek input, if necessary and where relevant to the objectives of this Agreement, from other existing bilateral discussions such as the Thailand-Australia Regional Security Dialogue, the Joint Working Group on Education and Training and other bilateral consultative mechanisms as appropriate.
- 5. The Joint Commission may also convene additional discussions or consultations at the Director-General or equivalent level to consider matters relating to the Agreement where it deems appropriate or when necessary.
- 6. The Joint Commission shall review progress in all areas of cooperation between the Parties and make recommendations concerning the enhancement of such cooperation and with regard to the activities of any committee or working group and the status of their cooperation.

#### **ARTICLE VII**

#### TERMINATION OF THE AGREEMENT ON ECONOMIC COOPERATION

The Agreement on Economic Cooperation between the Government of the Kingdom of Thailand and the Government of Australia, done at Bangkok on 6 August 1990, shall terminate on the date of entry into force of this Agreement.

# **ARTICLE VIII**

#### FINAL PROVISIONS

- 1. This Agreement shall enter into force on the date on which the Parties have notified each other in writing that their respective internal procedures for entry into force have been fulfilled. It shall remain in force until one Party gives written notice of its intention to terminate it, in which case this Agreement shall terminate six months after receipt of the notice of termination.
- 2. The revision or termination of this Agreement shall not affect the validity of arrangements already concluded and of guarantees given under this Agreement.
