DEAR SIRS.

IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY SHOULD NOT BE RATIFIED.

THIS EXECUTIVE DOES NOT SUPPORT ANY MONIES THAT ARE SENT TO A FOREIGN NATION FOR CITIZENS LIVING ON PENSIONS, FURTHER MORE WE DO NOT SUPPORT ANY IMMIGRATION POLICY THAT ALLOWS PERSONS TO RETAIN CITIZENSHIP, IF LIVING OUTSIDE OF THIS NATION AND NOT WORKING ON BEHALF OF AUSTRALIAN PARLIAMENTS.

IF THIS COUNTTY IS NOT GOOD ENOUGH TO LIVE IN,
AS A RESIDENT, THEN THESE PEOPLE SHOULD NOT BE ALLOWED TO
BLUDGE OF CENTERLINK, OR FELLOW AUSTRALIANS.

OBLIGATIONS ARE PLACED ON PENSIONERS AND THE UNEMPLOYED HERE IN AUSTRALIA, BUT NOT OVERSEAS, ALSO THE CURRENCY EXCHANGE RATE ALMOST DOUBLES, THIS TO US IS A BLATENT ATTEMPT TO MISUSE THE SYSTEM.
