Consultations

Consultation with Australian States and Territories

The Commonwealth briefed the States and Territories on the draft TOC Convention and its Protocols at the Heads of Commonwealth Operational Law Enforcement Agencies (HOCOLEA) meeting in November 1999 and again in April 2000.

- 2. The then Minister for Justice and Customs, Senator the Hon Amanda Vanstone wrote to the State and Territory Attorneys-General about the instruments in June 2000.
- 3. The matter was discussed at HOCOLEA again in June 2000.
- 4. The Commonwealth Government prepared a paper outlining the status of the negotiations for the Standing Committee of Attorneys-General (SCAG) meeting in July 2000.
- 5. The National Anti-Crime Strategy Lead Ministers were briefed on the TOC Convention and its Protocols in November 2000.
- 6. HOCOLEA was provided with a status report in February 2001 and the Commonwealth submitted a paper on the Convention to SCAG in March 2001. No jurisdiction expressed concern about the Convention and its Protocols in the SCAG context.
- 7. The Convention was discussed at the Senior Officers' Group Meeting of the Australasian Police Ministers' Council in May 2001.
- 8. Another status report was submitted to HOCOLEA in May 2001.
- 9. The Convention was discussed at the Standing Committee on Treaties (SCOT) meeting in May 2001. At that time, the Convention and the three Protocols had appeared on lists of multilateral treaty action under consideration tabled in the Commonwealth Parliament, and they had been on the SCOT list of treaties, for some time.
- 10. The Commonwealth received comments on the Convention and its Protocols from the Queensland Department of Justice and Attorney-General in March 2001. We have taken these comments into account in determining the domestic action required to comply with the obligations under the Convention.
- 11. The Convention and its Protocols were discussed again at the SCOT meeting in November 2003. At this meeting, the Commonwealth Government informed the States

and Territories of its intention to table the TOC Convention for consideration by the Commonwealth Parliament's Joint Standing Committee on Treaties.

12. The States and Territories did not express any negative comments.

Non-Government Consultation

- 13. The Australian Chamber of Commerce and Industry (ACCI) provided comments on the draft TOC Convention in July 2000. ACCI considered that the objectives of the Convention were 'sound and reasonable' but noted that enforcement of the Convention should not impede legitimate commercial activity.
- 14. Transparency International, an anti-corruption non-government organisation, supports ratification of the TOC Convention.
