Sydney public hearings for 457 visa

Federal Parliament's Migration Committee will be holding a public hearing in Sydney on 16 and 17 May as part of its inquiry into temporary business visas, including the 457 visa and labour agreements.

The Committee will hear from a diverse range of organisations, including Restaurant and Catering Australia, the Australian Manufacturing Workers Union, the Australian Meat Industry Council and the Migration Institute of Australia. The Committee will also hear from organisations representing the engineering, financial, tourism and transport sectors, as well as from some individual 457 visa holders.

Immigration department figures show that New South Wales was the largest user of the 457 visa program for the six months through to December 2006 compared to the other states and territories.

"The use of 457 visas is indicative of the skills shortage facing Australia in key industry sectors. We therefore want to see that the current arrangements for temporary business visas are functioning efficiently," Committee Chairman Don Randall said.

The Committee is examining the adequacy of current eligibility requirements for temporary business visas. It will also look at the effectiveness of compliance arrangements.
