## Commonwealth departments and industry groups attend 457 visa inquiry

Federal parliament's Migration Committee will be holding a public hearing in Canberra on Friday 1 June as part of its inquiry into temporary business visas, including the 457 visa and labour agreements.

The joint committee will hear from the Commonwealth departments of immigration, employment and workplace relations, and education.

"There has been plenty of discussion about the skills shortage facing Australia and the 457 visa in particular," committee chairman Don Randall said.

"We want to find out from these departments whether the current arrangements for temporary business visas are functioning efficiently or need to be improved."

The committee will also take evidence from the Australian Chamber of Commerce and Industry, the Australian Industry Group and the National Farmers Federation, along with the Australian Medical Association, Engineers Australia, and the Association of Professional Engineers, Scientists and Managers Australia. Multinational immigration consultancy Fragomen Australia and various academic groups will also appear before the committee.

The committee is examining the adequacy of current eligibility requirements for temporary business visas. It will also look at the effectiveness of compliance arrangements.
