Islam's most ratical followers boldly promise to destroy all other cultures so that the only religion that prevails is Islam and its Shari'ah Law.

This is not an idle threat. Western immigration policies have enabled rapid growth of Muslim people in Europe and USA. Followers of Islam are expected to exceed the population of other cultures these countries with in 20 -30 years.

I am only a novice in the study of Islam. I know enough to know it is a complex religion which seeks to control every part of a believer's life.

It is paramount that the people of Australia, particularly our political leaders and leaders generally, make a serious effort to seek out the truth about Islam from reliable sources.

The future of our nation and all its citizens, including Muslims, depends on a clear understanding of Islam and the wisdom and courage to take on the challenge head-on for the benefit of all people.

Recommendation:

That future immigrants and refugees be selected partly on the track record of their predecessors and their personal sincere willingness to be law abiding and embrace the existing conventions, laws and social structure of their host country.

Every nation should have the right to select people of good faith and reject immigrants and refugees that ultimately seek to destroy or undermine existing unity, social harmony and core values such as democratic governance and constitution, rule of law, freedom of religion, freedom of speech and artistic expression and general respect compassion for all humanity.

The Muslim community demands in Australia show that they have little respect for the Australia values mentioned above. Immigration for Muslims seems only a means to reap the benefits of the host countries' endeavours and ultimately bring a host nation to its knees in submission to Allah.

It is not good enough just to boycott Muslim terrorists. Muslims generally around the world should be condemned for the cruel aspects of their religious belief which has, and continues to be, the source of inhumanity to non-Muslims and Muslims alike. Muslim woman possibly being the most oppressed and abused.

The United Nations lack of condemnation of such Islamic atrocities highlights the power of Islamic world to bully humanity to accept acts of inhumanity carried out in the name of Islam.
