Inquiry into Multiculture

Dear Sir,

Thank you for this opertunity to express my opinions to the review.

I am English and now very happy with my inclusion in this society.

I am very pleased to live in this Multicultural environment.

I am not racist, and am very happy to have people from all races come and join our society. I am also pleased that they wish to join in our culture without changing it to the culture that they have left.

I wonder if the Government Social inclusion adjenda differs from assimilation?

Is it their intension to allow or make our culture look like or become the same as the one these Immigrants have left?

I have always understood that muliculturism was to enable the new immigrants to join our Christian based culture and to enable them to become part of it without making any basic changes to our society.

It is clear that our culture is an open society under pinned by our Christian Heritage, teachings and values. These allow the new immigrants to be welcomed and assimilated. This is how I want our society to continue to remain.

Recent issues have brought to light that the "Multicultural" society now seems to encourage people to come and establish ghettos of their "culture and world view" and never try to assimilate but to endeavour to establish a parallel universe in which they live, within our society.

They then by numerical supremacy seek to change the values and laws within their local communities. They never seem to want to become Australians but only seem to want to change Australia into a country which is like the one they have left.

The Muslim community is a case in point, as Islam is not only a religion but is also a system of government with its Sharia Law. The average Australian does not appreciate that this is inconsistent with our society.
