

7		A Commission must conduct its investigation as quickly as proper
8 9		consideration of the allegation permits. Generally, it must also hold any hearings in public.
10 11		A Commission has various powers of investigation, such as the power to do the following:
12		(a) hold a hearing;
13 14		(b) require a witness to appear at a hearing, and arrest a person who fails to appear;
15 16		(c) require the production of a document or other thing;
17		(d) issue search warrants.
18		The Commonwealth is liable for the reasonable costs of legal
19		representation for a Commonwealth judicial officer in relation to
20 21		whom an investigation is being conducted. Witnesses are entitled to be reimbursed for their expenses.
