## Customs Tariff Proposal No. 4 (2003)

### Motion moved by the Parliamentary Secretary to the Minister for Finance and Administration on 25 June 2003

1. That the *Customs Tariff Act 1995*, as proposed to be altered by Customs Tariff Proposals, be further altered:
  - (a) if the *Customs Tariff Amendment Act (No. 1) 2003* receives the Royal Assent on or before 1 July 2003—as set out in Schedule 1 to this Proposal and that the further alterations operate on and from:
    - (i) in the case of the alterations set out in Part 1 of Schedule 1 to this Proposal—on 1 July 2003 immediately after the commencement of Schedule 2 to the *Customs Tariff Amendment Act (No. 1) 2003*; and
    - (ii) in the case of the alterations set out in Part 2 of Schedule 1 to this Proposal—immediately after the commencement of Schedule 3 to the *Customs Tariff Amendment Act (No. 1) 2003*; and
  - (b) if the *Customs Tariff Amendment Act (No. 1) 2003* receives the Royal Assent after 1 July 2003—as set out in Schedule 2 to this Proposal and that the further alterations operate on and from:
    - (i) in the case of the alterations set out in Part 1 of Schedule 2 to this Proposal—on 1 July 2003; and
    - (ii) in the case of the alterations set out in Part 2 of Schedule 2 to this Proposal—on 1 July 2003 immediately after Schedule 2 to the *Customs Tariff Amendment Act (No. 1) 2003* is taken to have commenced; and
    - (iii) in the case of the alterations set out in Part 3 of Schedule 2 to this Proposal—immediately after the commencement of Schedule 3 to the *Customs Tariff Amendment Act (No. 1) 2003*.
2. That in this Proposal, “Customs Tariff Proposals” means:

Customs Tariff Proposal No. 3 (2002) introduced into the House of Representatives on 16 September 2002; and

Customs Tariff Proposal No. 1 (2003) introduced into the House of Representatives on 27 March 2003; and

Customs Tariff Proposal No. 2 (2003) introduced into the House of Representatives on 27 March 2003; and

Customs Tariff Proposal No. 3 (2003) introduced into the House of Representatives this day.
