Private senator's bill to be debated

On 14 November 2013 the Senate <u>agreed to</u> a temporary order allowing private senators' bills to be considered on Thursdays. On 26 March 2015 the Environment Protection and Biodiversity Conservation Amendment Bill 2014 is scheduled for debate
