Tuesday, 12 May 2015

The Senate met from 12.30 pm until 9.55 pm

Budget 2015-16

Budget Papers, Portfolio Budget Statements and related sites

The Minister for Finance (Senator Cormann) <u>tabled</u> the Budget statement for the year 2015-16 and associated budget papers and ministerial statements

The Senate <u>referred</u> budget documents to legislation committees to enable them to consider estimates. Estimates hearings will take place from 25 May to 4 June 2015

The Opposition and other parties will make their responses to the Budget statement on Thursday, 14 May 2015

Biosecurity Bill 2014 and 4 related bills—second reading agreed to—Australian Greens and Senator Xenophon second reading amendments negatived—committee of the whole commenced [further amendments remain to be considered]

- Customs Amendment (Anti-dumping Measures) Bill (No. 1) 2015—bill agreed to with Opposition and Senator Xenophon amendments [The House of Representatives will now consider the amendments made by the Senate]
- Customs Tariff (Anti-Dumping) Amendment Bill 2015—<u>bill agreed to</u> <u>with Senator Xenophon amendments</u> [The House of Representatives will now consider the amendments made by the Senate]

On 14 November 2013 the Senate agreed to a temporary order allowing private senators' bills to be considered on Thursdays. On 14 May 2015 the Food Standards Amendment (Fish Labelling) Bill 2015 is scheduled for debate

The President informed the Senate of the death, on 9 May 2015, of the Honourable Michael John Randal MacKellar, AM, a former minister and member of the House of Representatives for the division of Warringah from 1969 to 1994. A motion of condolence moved by the Leader of the Government in the Senate (Senator Abetz) was carried [first speaker]
