Mr President

I give notice that on the next day of sitting, I shall move that the Senate—

- (a) notes that the 'luxury' car tax imposes a burden of an estimated \$1,000 on popular cars such as the Ford Ranger, Ford Focus, Toyota Corolla and \$1,300 on the Toyota Hilux, Mitsubishi Triton, Holden Colorado and Nissan Navara,
- (b) further notes that former South Australian Labor Treasurer Tom Koutsantonis called for the axing of the luxury car tax, citing that it would improve access to electric, hybrid and hydrogen vehicles,
- (c) also notes that the Australian Automobile Association assert that the tax operated to protect a domestic Australian automotive manufacturing industry an industry that no longer exists and further estimates that the tax will add \$5 billion to the cost of new cars over the next 4 years,
- (d) observes that in January then Deputy Prime Minister Barnaby Joyce voiced support for axing the tax, and
- (e) calls upon the government to abolish or reduce the impact of the luxury car tax on Australian car buyers.
