SELECTION OF BILLS COMMITTEE

REPORT NO. 15 OF 2018

1. The committee met in private session on Wednesday, 5 December 2018 at 7.28 pm.
2. The committee recommends that—
 - (a) the Corporations (Aboriginal and Torres Strait Islander) Amendment (Strengthening Governance and Transparency) Bill 2018 be *referred immediately* to the Finance and Public Administration Legislation Committee for inquiry and report by 11 February 2019 (see appendix 1 for statements of reasons for referral);
 - (b) contingent upon introduction in the House of Representatives, the *provisions* of the Export Finance and Insurance Corporation Amendment (Support for Infrastructure Financing) Bill 2018 be *referred immediately* to the Foreign Affairs, Defence and Trade Legislation Committee for inquiry and report by 6 February 2019 (see appendix 2 for a statement of reasons for referral);
 - (c) the *provisions* of the Future Drought Fund Bill 2018 and Future Drought Fund (Consequential Amendments) Bill 2018 be *referred immediately* to the Finance and Public Administration Legislation Committee for inquiry and report by 8 February 2019 (see appendix 3 for a statement of reasons for referral);
 - (d) the Galilee Basin (Coal Prohibition) Bill 2018 be *referred immediately* to the Environment and Communications Legislation Committee for inquiry and report by 13 February 2019 (see appendix 4 for a statement of reasons for referral);
 - (e) the Lower Tax Bill 2018 be *referred immediately* to the Economics Legislation Committee for inquiry and report by 2 April 2019 (see appendix 5 for a statement of reasons for referral);
 - (f) the *provisions* of the Migration Amendment (Streamlining Visa Processing) Bill 2018 be *referred immediately* to the Legal and Constitutional Affairs Legislation Committee for inquiry and report by 25 February 2019 (see appendix 6 for a statement of reasons for referral);
 - (g) contingent upon introduction in the House of Representatives, the *provisions* of the National Disability Insurance Scheme Amendment (Worker Screening Database) Bill 2018 be *referred immediately* to the Community Affairs Legislation Committee for inquiry and report by 8 February 2019 (see appendix 7 for a statement of reasons for referral);
 - (h) the Parliamentary Joint Committee on the Australia Fund Bill 2018 be *referred immediately* to the Economics Legislation Committee for inquiry and report by 3 April 2019 (see appendix 8 for a statement of reasons for referral);
 - (i) the *provisions* of the Social Services and Other Legislation Amendment (Supporting Retirement Incomes) Bill 2018 be *referred immediately* to the

Economics Legislation Committee for inquiry and report by 11 February 2019 (see appendix 9 for a statement of reasons for referral); and

- (j) contingent upon introduction in the House of Representatives, the *provisions* of the Treasury Laws Amendment (Consumer Data Right) Bill 2018 be *referred immediately* to the Economics Legislation Committee for inquiry **but was unable to reach agreement on a reporting date** (see appendix 10 for a statement of reasons for referral).


