The Australian Electoral Officer for the State of South Australia cause to be undertaken a special count of the ballot papers cast for candidates for election for the Senate pursuant to the writ issued by the Governor of South Australia dated 16 May 2016 for the election of 12 Senators for the State of South Australia for the purpose of determining the candidate entitled to be elected to the place for which Robert Day was returned.

- The special count of the ballot papers be conducted in accordance with the directions set out in the Schedule hereto.
- There be liberty to apply to a justice of the Court in respect of any further questions which may arise as to the method of counting of the ballot papers.
- 4. Upon completion of the special count, the Australian Electoral Officer for the State of South Australia report to the Court the twelve (12) candidates who, in order, would be elected upon application of the rules for counting set out in s 273 of the Commonwealth Electoral Act 1918 (Cth) (CEA).

SCHEDULE OF DIRECTIONS

- A vote indicated on a ballot paper opposite the name of Robert Day be counted to the candidate next in the order of the voter's preference and the numbers indicating subsequent preferences be treated as altered accordingly.
- 2. The special count be conducted, subject to direction (1), as nearly as practicable in accordance with s 273A CEA as if there were 12 vacancies to be filled.
- 3. The special count identify which candidate is entitled to be elected to the place left unfilled by the ineligibility of Robert Day.
- 4. The special count identify which of the candidates other than Robert Day would be elected upon application of the rules for counting set out in s 273 CEA.
- 5. Notwithstanding direction (1) any ballot paper ruled to be informal during the 2016 scrutiny be treated as informal in the special count.
- 6. Notwithstanding direction (1) any ballot paper ruled to be formal during the 2016 scrutiny be treated as formal in the special count.
- 7. Notwithstanding direction (1) any ballot paper showing the same preference for Robert Day and one or more other continuing candidates be set aside as exhausted in accordance with subsection 273(26) CEA at the point in the count at which it would have been set aside had Robert Day been a candidate eligible for election.
- 8. The special count be open to the inspection of scrutineers.
