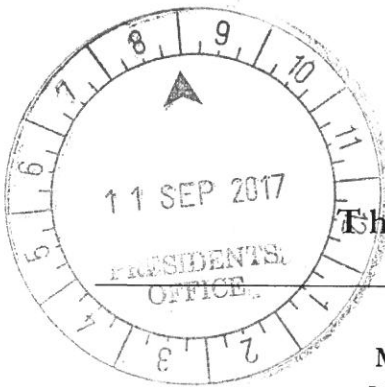

STATEMENT FROM THE MINISTER FOR TRADE, TOURISM AND INVESTMENT**

I present to you the following statement in compliance with the Senate Order of 25 June 2014 concerning *Estimates Hearings—Unanswered questions on notice—Order for production of documents*. This statement is in relation to questions taken on notice by the Australian Trade and Investment Commission (Austrade) during the 2017–18 Budget Estimates hearings in June 2017.

- (a) Austrade took 68 questions on notice at the Foreign Affairs, Defence and Trade Legislation Committee Budget Estimates hearing on 1 June 2017.
- (b) 34 answers were provided to the Committee by the date set by the Committee for answers.
- (c) 34 answers were not provided to the Committee by the due date of 21 July 2017. These answers were received by my office on 12 July 2017.
