We present to you the following statement in compliance with the Senate order of 25 June 2014, concerning *Estimates Hearings-Unanswered questions on notice-Order for production of documents* (page 1003 of the 25 June 2014 *Journals of the Senate* refers).

- (a) The Department of Foreign Affairs and Trade (DFAT) received 131 Questions on Notice (QoN) from the Foreign Affairs, Defence and Trade Legislation Committee Budget Estimates hearings on 31 May and 1 June 2017.
- (b) DFAT provided 131 QoN responses to the Committee by 7 August 2017.
- (c) The Department delivered its responses to both approving Minister's office 10 July 2017.
- (d) Due to Ministerial travel, the approval process could not be finalised by the Committee's tabling deadline of 21 July. Instead, 98 responses were provided to the Committee Secretariat on 25 July and a further 33 responses were provided on 7 August.
