General Business Notice of Motion

Amendment to standing order 24

(at the giving of notices on 16 November 2017)

Senator Polley (on behalf of the Scrutiny of Bills Committee)

Mr President

On behalf of the Standing Committee for the Scrutiny of Bills, I give notice that on Wednesday, 29 November 2017, I shall move that—

- (a) the Senate adopt the recommendation at paragraph 4.10 of *Scrutiny Digest 13 of 2017* of the Standing Committee for the Scrutiny of Bills, proposing an amendment to standing order 24; and
- (b) the temporary order of the Senate of 29 November 2016 concerning an amendment to standing order 24 cease to have effect.

Extract from the Scrutiny of Bills Committee's Scrutiny Digest 13 of 2017:

4.10 Standing order 24 be amended as follows with immediate effect:

At the end of paragraph (1), add:

- (d) The committee shall maintain on its website a list of bills in relation to which the committee has sought advice from the responsible minister and not yet received a response.
- (e) Where the committee has not finally reported on a bill because a ministerial response has not been received, then:
 - (i) immediately prior to the consideration of government business on any day; or Olodged

- (ii) immediately prior to the consideration of the bill, any senator may ask the minister for an explanation of why the minister has not provided a response to the committee.
- (f) Where an explanation is sought under paragraph (e) and a minister provides an explanation, then at the conclusion of the explanation the senator may move, without notice, a motion:
 - (i) relating to the consideration of the bill; or
 - (ii) that the Senate take note of the explanation.
- (g) Where an explanation is sought under paragraph (e) and the minister does not provide an explanation, then the senator may, without notice, move a motion relating to:
 - (i) the consideration of the bill; or
 - (ii) the minister's failure to provide an explanation.
- (h) The procedures in paragraphs (e) to (g) may only be used once on any sitting day in respect of any bill or bills taken together.



I give notice that, on the next day of sitting, I shall move—That the time for the presentation of the report of the Select Committee on Lending to Primary Production Customers be extended to 6 December 2017.

I give notice that on 27 November 2017, I shall move— That the Senate —

- (1) notes:
 - (a) the Australian Information Commissioner Act 2010 (AIC Act) establishes three independent statutory office holders:
 - i. the Information Commissioner,
 - ii. the Freedom of Information (FOI) Commissioner, and
 - iii. the Privacy Commissioner;
 - (b) paragraphs 11(5)(a) and (b) and paragraphs 12(5)(a) and (b) of the AIC Act describe the independence of each commissioner;
 - in the six months following the AIC Act's Royal assent three commissioners were appointed to the three office holder's positions;
 - (d) since the unsuccessful attempt by the Abbott Government to abolish the Office of the Australian Information Commissioner, two commissioners have left office and have not been replaced;
 - (e) currently Mr Timothy Pilgrim fills the statutory position of Information Commissioner and Privacy Commissioner and the position of FOI Commissioner is vacant on account of Mr Pilgrim not holding the legal qualifications required in paragraphs 14 of the AIC Act;
 - (f) The AIC Act requires the appointment of three independent statutory office holders and the Government is constitutionally bound to maintain and execute the laws of the land and uphold the will of the Parliament.
- (2) Calls on the Government to immediately commence the process of appointing an independent Privacy Commissioner and an independent FOI Commissioner in accordance with the AIC Act.
