111.01 *Prime Minister introduces bill*

On Wednesday 13 November, the Prime Minister introduced the Clean Energy Legislation (Carbon Tax Repeal) Bill 2013, presented an explanatory memorandum to the bill and to related bills, and made a second reading speech. Eleven related bills were then introduced by other Ministers.

Note: While allowed by the standing orders, it is relatively rare for a Prime Minister to introduce a bill (*see* entry **108.02** for a previous occurrence).

111.02 *Suspension of standing orders — Introduction and passage of bill — Extended sitting*

On Wednesday 13 November, the Leader of the House sought leave to move a motion to suspend standing and sessional orders to facilitate the introduction and passage of the Commonwealth Inscribed Stock Amendment Bill 2013. Leave was not granted and the Leader of the House proceeded to move the motion without leave.

The motion provided for the withdrawal of a separate notice of motion relating to the passage of the bill, and for the bill to proceed through all stages that day, applied time limits to the stages of the bill's consideration and restrictions on questions to be put.

Following debate, the motion was agreed to by an absolute majority on division and the bill was introduced. Debate resumed on the bill immediately, and was interrupted at 7 p.m. for summing-up in accordance with the terms of the resolution. The second reading was carried on the voices, a message from the Governor-General was announced and the bill was then considered in detail. Following debate, an Opposition amendment was negatived on division, and the bill was then agreed to and read a third time on the voices.

In accordance with the resolution, proceedings were not interrupted at 7.30 p.m. for the automatic adjournment, continuing until approximately 8.10 p.m.

111.03 *Amendment moved to second reading amendment*

On Thursday 21 November, during debate on the second readings of the Clean Energy Legislation (Carbon Tax Repeal) Bill 2013 and ten related bills (*see entry 111.15*) and on a second reading amendment to the main bill (which had been moved at an earlier sitting by an Opposition Member), the Australian Greens Member moved an amendment to the proposed second reading amendment. The amendment was seconded and debate continued on the question that the amendment moved to the proposed second reading amendment be agreed to.

The House divided on the amendment to the proposed second reading amendment and, with only two Members voting aye, the Speaker declared the question negatived. The second reading amendment was then negatived on the voices, and the second readings of the bills were agreed to on division (*see entry 111.04* for further proceedings).

Note: Prior to June 2011, questions on second reading amendments were put in the form: "That the words proposed to be omitted stand part of the question". This generally enabled Members to remain on their own side of the Chamber during a division on the question, but when stated in this form further amendments could not be moved. Questions on most types of amendments are now put in the form: "That the amendment(s) be agreed to".

111.04 *Proposed amendment ruled out of order – Dissent motion moved and negatived*

Immediately prior to consideration in detail of the Clean Energy Legislation (Carbon Tax Repeal) Bill 2013 and ten related bills (*see entries 111.15 and 111.03*) on 21 November, the Speaker made a statement concerning proposed amendments to the main bill which had been circulated by an Opposition Member. The Speaker ruled that the amendments could be argued to constitute the initiation of a proposal to impose, increase or change the scope of a charge, contrary to standing order 179(a), and that they could increase or extend the scope of the charge proposed beyond the total already existing under any Act of Parliament, contrary to standing order 179(b).

Following several points of order from both sides of the House, the Manager of Opposition Business moved that the Speaker's ruling be dissented from. After the

mover and seconder had spoken, the Leader of the House spoke to the motion and moved that the question be now put. The question was carried on division, and the question that the Speaker's ruling be dissented from was then negatived on a subsequent division.

The bills were then considered in detail without any amendments being moved and, later, were agreed to and read a third time.

111.10 *Attempt to suspend standing orders to require explanation by Minister*

After prayers on Wednesday 13 November, the Manager of Opposition Business sought leave to move a motion to allow the House to note commitments made by the Government and to require the Immigration Minister to attend and give an explanation to the House. Leave was not granted. He then moved to suspend standing orders to allow him to move the motion. After the motion had been outlined to the House, the Leader of the House moved that the Member be no longer heard, which was carried on division. After an Opposition Member seconded the motion, the Speaker read the terms of the motion to the House on request by the Manager of Opposition Business. The Leader of the House began speaking to the motion, and was interrupted by a point of order and subsequent motion of dissent in the Speaker's ruling. Following proceedings on the dissent motion (*see* entry **111.43**), the time for debate on the suspension motion had expired, and the motion was negatived on division.

During question time on 14 November, the Leader of the Opposition sought leave to move a motion concerning the Government's actions in respect of asylum seekers. Leave was not granted. The Leader of the Opposition then moved, without notice, a suspension of standing orders to enable him to move the motion. The motion was debated and negatived on division and question time concluded.

Later, when the discussion of a matter of public importance was called on, the Leader of the House moved that the business of the day be called on. The motion was agreed to on division.

On Monday 18 November the Leader of the House moved, pursuant to notice, a motion to suspend standing and sessional orders to modify the usual proceedings for the consideration of the Clean Energy Legislation (Carbon Tax Repeal) Bill 2013 and ten related bills.

The motion provided for a concurrent second reading debate on the eleven bills, and set a deadline of 12 noon on Thursday 21 November for the conclusion of the debate. The motion also prescribed the number of questions to be put on the second readings of the bills including second reading amendments, on consideration in detail amendments, and those put on the remaining stages of the bills. The motion set a 60 minute limit on the consideration in detail debate, with the bills taken together.

Following debate, the motion was carried on division and the second reading debate on the bills commenced.

111.45 *Question to the Speaker regarding use of Twitter*

Following proceedings on a dissent motion (*see* entry **111.04**) on Thursday 21 November, the Leader of the House raised a point of order to advise the Speaker that two Members had, on social media, reflected on the impartiality of the Chair. He asked the Speaker to consider whether this was disorderly conduct and whether any action should be taken.

The Speaker responded that while the use of electronic media was permitted in the Chamber, the same rules apply as for speaking in the House. On a subsequent point of order, one of the Members concerned apologised for his actions. Later in the sitting, the Speaker reported to the House that the matter had been resolved to her satisfaction.

Standing orders

111.46 *Amendments to standing orders and new resolution*

During government business time on 13 November, the Leader of the House sought leave to amend his notice of motion to amend the standing orders. Leave was not granted, and he moved the motion as it appeared on the *Notice Paper*. The amendments proposed included changes to meeting times, speaking times, the

orders of business for the House and Federation Chamber, procedures concerning question time and private Members' business, the structure and operation of committees, interventions, and the movement of business between the House and Federation Chamber. The motion also included a proposed resolution on procedures for dealing with committee witnesses.

Debate ensued, and the Greens Member moved four amendments to the motion. Following further debate, Leader of the House moved that the question be put, which was agreed to on division. The question on the amendments was then negatived on division. The Leader of the House then moved that the (original) question be put, which was agreed to on division, and the amendments to the standing orders and the proposed new resolution were agreed to on the subsequent division.

The following day, the Leader of the House moved, pursuant to notice, amendments to standing order 215. The amendments changed the names and membership provisions of general purpose House standing committees, and were agreed to on the voices.
