

#### **Bills**

#### 115.01 Consideration of Senate amendments to bill

On Tuesday 18 March, debate resumed on the consideration of Senate amendments to the Social Services and Other Legislation Amendment Bill 2013 which were reported to the House on 6 March. The Minister for Social Services moved that certain of the amendments be agreed to and the motion was carried on the voices. The Minister then moved that certain other amendments be disagreed to and moved that two Government amendments be made in their place. The motion was agreed to on the voices.

On Tuesday 25 March, a message was received from the Senate informing the House that the Senate did not insist on its amendments disagreed to by the House and had agreed to the amendments made by the House in their place.

#### Proceedings on the Land Transport Infrastructure Amendment 115.02 Bill 2014

On Monday 24 March, second reading debate resumed on the Land Transport Infrastructure Amendment Bill 2014. The bill was read a second time and considered in detail. The Shadow Minister for Infrastructure and Transport, by leave, moved two groups of Opposition amendments together. Debate ensued, and the amendments were negatived on division. The Shadow Minister then moved another Opposition amendment. Debate ensued and the amendment was negatived on division. The Chair then put the question 'that the bill be agreed to', which was agreed to on division. Leave was granted for the third reading to be moved immediately and the bill was read a third time.

*Note:* The division on the question 'that the bill be agreed to' was the first instance of a successive division following amendments to standing order 131 (regarding the timing and recording of successive divisions) which were agreed to by the House on 19 March (see entry 115.32)

**115.03** Second reading amendment moved; fewer than five Members vote on one side during division

On Tuesday 25 March, debate resumed on the second reading of the Defence Force Retirement Benefits Legislation Amendment (Fair Indexation) Bill 2014. A non-aligned Member moved a second reading amendment which was seconded by another non-aligned Member. When the question was put on the second reading amendment, a division was called. Four Members (non-aligned) voted on the side of the ayes. There being fewer than five Members on one side, the Chair declared the question negatived without completing the count and the names of those in the minority were recorded in the Votes and Proceedings.

**115.04** Proceedings on the Clean Energy Finance Corporation (Abolition) Bill 2013 [No. 2]

On Thursday 27 March, debate resumed on the second reading of the Clean Energy Finance Corporation (Abolition) Bill 2013 [No. 2]. Debate was interrupted at 12.00 p.m. in accordance with the programming motion agreed by the House earlier that day (*see* entry **115.16**). The Parliamentary Secretary to the Treasurer summed up the second reading debate and the question on the second reading was put, and agreed to on the voices.

The House then considered the bill in detail, as a whole, by leave. After one hour of consideration in detail, the Speaker put the question that the bill be agreed to, in accordance with the programming resolution agreed to earlier. A division was called and, during the ringing of the bells, the Speaker declared the question carried after the Manager of Opposition Business indicated that the Opposition did not wish to proceed with a division.

The Parliamentary Secretary then moved, by leave, that the bill be read a third time. The question was agreed to on division and the bill was read a third time.

The Speaker informed the House that she had ascertained that Her Excellency the Governor-General would be pleased to receive the Address in Reply at Government House at 4.00 p.m. that afternoon and that the sitting would be suspended at 3.30 p.m. The Speaker said that she would be glad if the mover and seconder, together with other Members, would accompany her to present the Address.

The Speaker informed the House that the Governor-General had been pleased to make the following reply: "Madam Speaker, Thank you for your Address in Reply. It will be my pleasure and my duty to convey to Her Majesty The Queen the message of loyalty from the House of Representatives, to which the Address gives expression."

# **115.12** Attempt to suspend standing orders to require Prime Minister to make a statement regarding a former Minister

During question time on 20 March, the Leader of the Opposition sought leave to move a motion to require the Prime Minister to immediately explain to the House all the information in his possession in relation to the former Assistant Treasurer's involvement in Australian Water Holdings. Leave was not granted. The Leader of the Opposition then moved a suspension of standing orders to enable him to move the motion and debate ensued. The suspension motion was negatived on division.

### **115.13** Attempted suspension of standing orders to consider disallowance motions

The notices related to the disallowance of the Military Rehabilitation and Compensation Act Education and Training Scheme (Income Support Bonus) Repeal Determination 2014 and the Veterans' Children Education Scheme (Income Support Bonus) Repeal Instrument 2014. Leave was not granted.

The Leader of the Opposition then moved to suspend standing orders to allow the notices to be called on. Debate ensued, and the suspension motion was negatived on division.

### **115.14** Standing orders suspended to enable programming of government business

The Leader of the House, by leave, moved that the resumption of debate on the condolence motion be referred to the Federation Chamber and the motion was agreed to.

The condolence motion was returned to the House on 27 March after being debated for approximately two hours, and agreed to as all Members again rose in their places.

#### 115.32 Amendments to standing orders agreed to

During Government business time on Wednesday 19 March, the Leader of the House, pursuant to notice, moved amendments to standing orders 131(b) and 207(b). The amendment to standing order 131(b) sought to substitute the word 'take' for 'record' to provide that in successive divisions, 'the tellers shall <u>take</u> each Member's vote as being the same as it was in the previous division unless a Member reports to them.' The amendment to standing order 207(b) sought to clarify that petitions could be presented during the period for Members' 90 second statements in the Federation Chamber on Mondays. Both amendments were agreed to on the voices.

The Leader of the House then, pursuant to notice, moved an amendment to standing order 1 to establish time limits for debate on motions relating to the programming of Government business. The amendment was agreed to on the voices.

The Leader of the House then, pursuant to notice, moved an amendment to standing order 131(a) to provide that the bells shall be rung for one minute where a successive division is called no more than three minutes following a division. Previously, if there was intervening debate between two divisions, the bells were required to be rung for four minutes. The amendment was agreed to on the voices.
