

#### **Bills**

**121.01** Fewer than five Members vote on one side during division

On Wednesday 24 September, when the question was put on the second reading of the Tax and Superannuation Laws Amendment (2014 Measures No. 5) Bill 2014, a division was called. Two non-aligned Members voted with the 'Noes' and, in accordance with standing order 127, the Chair declared the question carried without completing the count and the names of those in the minority were recorded in the Votes and Proceedings. The Parliamentary Secretary to the Treasurer, by leave, then moved that the bill be read a third time. The question was carried on the voices and the bill was read a third time.

**121.02** Fewer than five Members vote on one side during divisions on four occasions during consideration of national security bill

On Wednesday 1 October, when the question was put on the second reading of the National Security Legislation Amendment Bill (No. 1) 2014, a division was called. Three non-aligned Members voted with the 'Noes' and in accordance with standing order 127, the Chair declared the question carried without completing the count and the names of those in the minority were recorded in the Votes and Proceedings.

The bill was then considered in detail and, by leave, taken as a whole. A non-aligned Member, by leave, moved certain amendments together. Following debate, the question on the amendments was put, and a division was called. Three non-aligned Members voted with the 'Ayes' and in accordance with standing order 127, the Chair declared the question negatived without completing the count and the names of those in the minority were recorded in the Votes and Proceedings. The non-aligned Member then, by leave, moved certain other amendments together and again, a division was called and three non-aligned Members voted with the 'Ayes' and in accordance with standing order 127, the Chair declared the question negatived without completing the count.

Another non-aligned Member then, by leave, moved certain amendments together. The ensuing debate was closured on motion moved by the Assistant Minister for Defence and carried on the voices. The question on the amendments was put and a division was called. Three non-aligned Members voted with the 'Ayes' and in accordance with standing order 127, the Chair declared the question negatived without completing the count and the names of those in the minority were recorded in the Votes and Proceedings. The bill was then agreed to on the voices and consideration in detail concluded. The Assistant Minister for Defence, by leave, moved that the bill be read a third time. The motion was carried on the voices and the bill was read a third time.

#### **121.03** Bill introduced and passes all stages in one sitting

During Government business time on Thursday 2 October, the Minister for Social Services presented the Social Services and Other Legislation Amendment (2014 Budget Measures No. 6) Bill 2014 and an explanatory memorandum, and made a second reading speech. Leave was granted for debate on the second reading to continue immediately. After contributions from the Leader of the Opposition and a Shadow Minister, the Minister summed up the debate. The question that the bill be read a second time was carried on the voices and a message from the Governor-General recommending an appropriation for the purposes of the bill was reported. Leave was granted for the third reading to be moved immediately, the motion was carried on the voices, and the bill was read a third time.

### **121.13** House agrees to Senate resolutions appointing two joint select committees

During Government business time on Monday 22 September, messages were reported from the Senate transmitting resolutions agreed to by the Senate relating to the establishment of a Joint Select Committee on the Australia Fund Establishment and a Joint Select Committee on Trade and Investment Growth. Each message requested the concurrence of the House in the resolutions. The House deferred consideration of the resolutions to the next sitting day.

On 23 September, when each of the two orders of the day relating to the consideration of the Senate messages was called on, the Leader of the House moved that the House concur with the resolution and send a message to the Senate acquainting it of the resolution. On each occasion, the motion was carried on the voices.

**121.15** Point of order seeking the Speaker's intervention under standing order 68 (repetition of matters corrected by personal explanation)

During the Prime Minister's response to a question without notice from a Shadow Minister on Tuesday 30 September, the Shadow Assistant Treasurer raised a point of order and requested that the Speaker intervene on the grounds that the Prime Minister was repeating a claim previously corrected by personal explanation. The Speaker indicated that she would review the Prime Minister's remarks after question time.

The following day, after question time, the Speaker made a statement on the matter and indicated that if the Prime Minister wished to refer to views expressed in a book written by the Shadow Assistant Treasurer, he must make this clear so as not to infringe standing order 68. She noted that in the previous day's case, this was not clear, and the Shadow Assistant Treasurer had been entitled to invoke standing order 68.

# **121.24** Statements by Speaker regarding Parliament House security and the installation of screens in the Chamber

After the acknowledgement of country and prayers on Monday 22 September, the Speaker made a statement regarding changes to security practices and procedures in Parliament House which had been designed to strengthen existing security arrangements. The Speaker asked Members to be patient as the new procedures were implemented.

The Speaker also made a statement about the installation of screens in the corners of the Speaker's end of the Chamber, to display the current matter and question before the House. The installation of the screens followed a request to the Speaker by the Procedure Committee earlier in the year.

## **121.25** Question to Speaker regarding responsibilities of the Chair and use of social media

After question time on Wednesday 1 October, the Leader of the House asked a question to the Speaker as to whether or not the Second Deputy Speaker was in the chair as Deputy Speaker at the time that he posted a tweet reflecting on a Member's contribution to a debate. If so, the Leader of the House asked the Speaker whether it was appropriate for a Member of the Speaker's panel to reflect on other Members via social media while in the Chamber. The Speaker stated that the standing orders apply to social media and electronic devices just as they do to individuals within the Chamber. She said that she would consider whether or not it was the Second Deputy Speaker's tweet and whether the words alleged to have been tweeted were those which were tweeted and would report back to the House.

After question time the following day, the Speaker reported back to the House and stated: 'It is quite improper for occupiers of the chair whilst in the chair to reflect on the contributions of members, whether orally or by the use of social media.' The Speaker also informed the House that she would be instructing

occupants of the chair to refrain from using social media whilst they are in the chair, as they should be concentrating on the proceedings at hand.

# **121.26** Question to Speaker regarding reflections on members of the judiciary

After question time on 1 October, the Manager of Opposition Business asked the Speaker to consider an answer given by the Prime Minister to a question regarding the *Racial Discrimination Act 1975* and to ascertain whether the Prime Minister may have breached standing orders relating to reflections on members of the judiciary. The Speaker responded that 'a question as to whether or not a matter is prosecuted is not a reflection on the judiciary', but indicated that she would consider the matter.

After question time the following day, the Speaker noted that standing orders and practice of the House place certain constraints upon references in debate to members of the judiciary. However, she stated that the Prime Minister's remarks had focused on whether a matter should have been prosecuted, rather than on any member of the judiciary.
