Summary of policy (as applicable, please attach copies of relevant policy documents):	Allow ARENA to enter into new spending commitments and restore the Australian Renewable Energy Agency's (ARENA's) appropriation provided in the 2016-17 financial year to the levels it was at prior to changes from Schedule 5 of the <i>Clean Energy Legislation (Carbon Tax Repeal) Act 2014</i> , namely \$299,550,000. The existing appropriation schedule beyond 2016-17 would remain unchanged.

To support research and pre-commercial development of renewable energy technologies and projects as a contribution to decarbonisation of the economy, and fulfil our obligations to innovation investment made by the Turnbull government at the 21 st UN Conference of the Parties in Paris, December 2015.
