Summary of policy (as applicable, please attach copies of relevant policy documents):	Invest \$188 million into a Sustainable Schools Programme that schools can bid into – perhaps on a co-contribution basis – to pay for minor sustainability infrastructure works for purposes such as energy efficiency, energy capture, water capture etc.  It is modelled on the Reducing Carbon Footprint of Schools programme administered by the Tasmanian Government in 2013-14
What is the purpose or intention of the policy?	To achieve environmental sustainability outcomes whilst also reducing local fixed utility costs. School savings can then be spent in the classroom instead.
