Q: At Budget Estimates hearings on 29 May 2007, Senator Moore asked Ms Stawyskyj how much the department will spend on publicity for the Social Security Agreement between Australia and Greece.

A: The Department has been allocated \$110,450 for publicity and community consultation on the Agreement. Community consultation will begin in June with the posting of information to Greek community groups, welfare organisations and State and Territory Governments.

Fact Sheets will be printed and distributed to key organisations in 2008 for distribution as needed.

Advertisements will be placed in major metropolitan, primary regional and Greek language newspapers in 2008, closer to the commencement date of the Agreement. There will also be some SBS radio.

Centrelink will undertake some separate publicity in 2008 that will involve articles in the News for Seniors, Australian Pension News and The Journey Magazine.

- g) Given that there are no specific recommendations in the report, will FaCSIA consult with the sector before considering the approach any further? If not, why not?

Answer:

The report recognises that in addition to government funding FRSP service providers as independent non-government organisations derive income from a range of sources, such as private donations from auspice bodies or revenue generated through fees, to support the delivery of family relationship services. The report simply recognises these other financial inputs as necessary elements in the development of an FRSP cost methodology. The department does not propose that FRSP service delivery can or should be supported solely from fee income.

There has been no consideration of removing fees and implementing a two tiered system. The existing fee policy provides, above a minimum standard of exemptions designed to ensure accessibility for those on low incomes such as health care card recipients, flexibility for FRSP service providers to respond to the needs of their local communities.

The department is still considering the report and what further consultations may be required with the sector.

Data from the Child Support Agency shows that 4,850 customers were referred to the Family Relationship Advice Line or Family Relationship Centres in the period July 2006 to April 2007. (Note that those transferred to the Advice Line may be referred on to a face to face service but in many cases are provided with a service by Advice Line Parenting Advisers who are trained social workers).

The Minister did not approve any applications under VSEG 2004 Round Two that were not consistent with the program guidelines or that the department considered should not be funded.

What was the difference between what was announced in the election campaign and what was funded for the Eastern Access Community Health Group.

Answer:

The then Minister for Family and Community Services, Senator the Hon Kay Patterson, announced a commitment of nearly \$165,000 to support community health programs delivered by Eastern Access Community Health (EACH). The funding included \$99,000 for the *Risk It Recharge* Program for young people and \$65,000 for the purchase of two vehicles, including a minibus.

Eastern Access Community Health Group received \$165,000 funding for four youth projects, including \$18,703 for *Risk It Recharge*, and \$66,000 for two vehicles. The specific youth projects and budget items were determined in consultation with EACH during funding agreement negotiations. The funding breakdown is shown in the table below.
