Remote Jobs and Communities Program (RJCP) forward estimates

Ms Kidd: I will try to help. One is around the model itself, so we looked at the services that were existing in remote and we in effect took the funding and turned it into something else. Separately, there was a CDEP grandfathering measure, and that was also dealt with. In the budget papers, some of the funding is a bit mixed up between the two.

Senator PAYNE: If I was to point you to the establishment table for the program, which has as the savings in 2013-14, '14-15 and '15-16 respectively the total adds up to considerably more than the numbers that you have been talking about. Are those funds going somewhere else or just back into revenue?

Ms Kidd: There are two things we can do. We can try and reconcile that figure for you or we can go through the headlines of where the funding is and how much the offsets were. Which would be easier for you?

Senator PAYNE: If you were to do the latter, I suspect it would be much easier to take that on notice than to do it orally. That would be challenging for all of us. I am happy for you to provide that on notice.

Ms Kidd: We can give you quite a simple table that shows what the amounts are and what the offsets are.
