## Question:

Were experts consulted in relation to the elective surgery targets and emergency department targets? If so, who were they and when did that consultation occur?

#### Answer:

Yes.

The National Health and Hospitals Reform Commission (the Commission) was established in February 2008 and presented its final report, *A healthier future for all Australians*, in June 2009. This report recommended National Access Targets, including for elective surgery and emergency departments.

The Commission comprised the following members:

In relation to emergency department targets, in October 2010 the Australian Health Ministers' Advisory Council (AHMAC) agreed to establish a time-limited Cross Jurisdictional Clinical Advisory Group (CJCAG) to research and make recommendations on a nationally consistent

definition of patients for whom it is clinically appropriate to remain in emergency departments longer than four hours. CJCAG was established in December 2010, with membership consisting of the following emergency clinicians and jurisdictional representatives:

CJCAG's final report and recommendations were provided to AHMAC in early June 2011.

In February 2011 COAG agreed to establish an Expert Panel to review the elective surgery and emergency department targets.
