Senator Fifield asked:

What is the total number of reviews both completed and ongoing in the portfolio/agency or affecting the portfolio agency since Budget Estimates 2010?

Answer:

The definition of 'Reviews' used to answer this question is any review publicly initiated by the Department or by one of its portfolio Ministers. Other work relating to Cabinet committees, inter-departmental committees, Coalition of Australian Governments working groups and internal committees are excluded. This approach is consistent with previous responses and updates information provided in answers to Questions on Notice 018 to 021 from the 2009-10 Additional Estimates.

The Department has previously responded to similar questions on reviews from Senator Barnett (Budget Estimates Question on Notice 017 of June 2010, Additional Estimates Question on Notice 018 of February 2010 and Senate Question on Notice No S1846 of July 2007), Senator Humphries (Estimates Question on Notice 055 of February 2009), Senator Ronaldson (Senate Question on Notice No S952 of November 2008), and Senator Bernardi (Estimates Question on Notice No 031 of October 2008).

Since Budget Estimates Question on Notice 017 of June 2010 one review has been completed:
