Senator Cash asked:

With reference to the 42 Specialised Family Violence Services funded through a Family Support Program in 2009-2010:

- a. In which locations were these services provided.
- b. What was the extent of the funding for each of these locations?
- c. Which Specialised Family Violence Services locations will be funded in 2010-2011 and what is the anticipated funding for each of these locations.
- d. What governance procedures are in place to determine that the funding achieves value for money for the services provided?
- e. What key performance indicators are employed to determine the extent of value for money for the services provided?

Answer:

A table of Specialised Family Violence Services locations and funding for the 2009-10 and 2010-11 financial years, is at Attachment A.

Performance information (e.g. client characteristics and service usage) is collected by funding recipients and entered into or transferred to FRSP Online, the Family Support Program's online data collection system.

A funding recipient's performance is measured against Funding Agreement requirements, which include an annual Service Assessment, an annual Service Report, the timeliness of data input into FRSP Online, and meeting client targets which are specified in the Funding Agreement.

Client feedback forms, which are completed by registered clients at the end of service delivery, provide data on key performance indicators such as client satisfaction with the level of support they received from a service, their improved knowledge and skills relating to their presenting need, and improvement in their relationship with their partner. This enables the Department to monitor funding recipient's performance and determine value for money for the services provided.

With the implementation of the Family Support Program, a new Performance Framework is under development which will include additional performance indicators and data, which will assist in determining that Commonwealth funding achieves value for money for the services provided.

Service providers must also be compliant with Family Relationship Services Approval Requirements. These are a set of 15 standards including governance, data provision, training, confidentiality and safety. Compliance against these standards is externally assessed and reviewed by an independent body. Ongoing self-assessment against the Approval Requirements is recorded in the annual Service Report which is signed off by the funding recipient's Board. This process helps to provide families and staff with assurance that quality services are being delivered.
