Domestic Forums

Office for Women staff attend or participate in a wide range of domestic forums, conferences and meetings as part of their ongoing work of the Office. These include forums such as the 2008 National Rural Women's Summit, the National Women's Alliances Annual Forum, meetings with the National Women's Alliances, and conferences organised by Women on Boards and national or community based women's groups. Travel is funded from within the departmental budget. Provision of the detail requested would require a significant diversion of resources to respond.
