#### Notes to Table A:

- (1) The Social Housing Initiative provided \$5.638 billion over the three and a half years from 2008 to 2012. Funding has now finished for this program.
- (2) The National Partnership Agreement on Social Housing provided \$400 million over three and a half years from 2008 to 2011. Funding has now finished for the program.
- (3) The National Affordable Housing SPP commenced on 1 January 2009 and the Specific Purpose payment in 2009 was for the six months to June. Funding is ongoing under this agreement.
- (4) The total funding allocation for the National Partnership Agreement on Remote Indigenous Housing is \$5.5 billion over 10 years, finishing in 2017-18. This allocation includes the Commonwealth's Own Purpose Expenditure (COPE) which includes funding for a range of housing related programs.
- (5) Please note there are two parts to the National Rental Affordability Scheme (NRAS) forward estimates for FAHCSIA and for the Australian Tax Office (ATO) as the NRAS incentive is provided as a cash payment or a refundable tax offset.
- (6) NRAS actuals are shown from 2008-09 to 2010-11. The figure for 2011-12 is the appropriation (not the actuals) for FAHCSIA and the ATO.
- (7) The total allocation for the Housing Affordability Fund is \$413.35 million from 2008-09 to 2012-13. A total of \$352.543 million in administered funds have been paid by the program to date (October 2012) including \$4.952 million for this financial year. The breakdown for the expenditure and remaining commitment for 2012-13, as at end October 2012, is provided below:
