### **Question:**

Since 7 September 2013, how many new Reviews have been commenced? Please list them including:

- a) The date they were ordered
- b) The date they commenced
- c) The minister responsible

- e) The nature of the review
- f) Their terms of reference
- g) The scope of the review
- h) Who is conducting the review
- i) The number of officers, and their classification level, involved in conducting the review

## Answer:

Three reviews have commenced since 7 September 2013 (as at 22 January 2014); the Review of Medicare Locals, the Review of the Personally Controlled Electronic Health Record Program; and the National Mental Health Commission's Review of mental health programmes.

#### **Medicare Locals**

The Review will have three components:

- A review of the functioning of Medicare Locals to improve their effectiveness and efficiency, to be undertaken by Ernst & Young. This review will build on the Medicare Locals Evaluation, which concluded in December 2013.
- An Independent Financial Audit of all Medicare Locals. This will be undertaken by Deloitte Touche Tohmatsu Limited.
- An opportunity for stakeholder feedback to be provided directly to Government on the role and functioning of Medicare Locals. This will be managed by the Department of Health.

The Review will be overseen by Principal Medical Consultant to the Department of Health, Professor John Horvarth AO.

- i) External consultants as described above are undertaking elements of the Review. A departmental secretariat comprises:
  - 2 Executive Level 1 officers; and
  - 1 APS 6 officer.
- j) Advice is expected to be provided to the Government in March 2014.
