This Agency became the responsibility of the new Department of Social Services on 11 October 2013. For the purposes of this response, expenditure by this Agency is reported under the Department of Health and Ageing. To provide separate detail for the period 11 October 2013 to 31 October 2013 would involve an unreasonable diversion of resources which the Department is not currently in a position to undertake.

The Department is committed to providing executive coaching and leadership training for its staff to help achieve goals related to professional development and/or business performance. The Department centrally funds and manages a range of coaching and leadership training. This includes individual coaching, internal group leadership training and staff participation in external leadership courses through providers such as the Australian Public Service Commission or the Australian National University.

The coaching and training available has been utilised by officers from the Executive Level one to Senior Executive Service Band three levels. The time taken for these services varies from one hour executive coaching sessions through to external leadership training courses of several weeks.

The Department reinvigorated its approach to developing our management and leadership capability through commencement of a Middle Manager Development Program. This program focuses on providing executive level staff with practical tools and leadership skills to deliver the department's vision and strategy.
