Question:

What is the average annual payment or concession provided under the PBS to Territorians, and how it compares to the national average?

Answer:

People in the Northern Territory have three ways in which to receive access to subsidised medicines: through the Pharmaceutical Benefits Scheme (PBS), Closing the Gap – PBS Co-payment Measure; and the Section 100 Remote Area Aboriginal Health Service (RAAHS) Programme.

The PBS is available to all Australian residents who hold a current Medicare card. Only those eligible for the PBS will receive subsidised medication and every time they present their script to the pharmacist, they need to provide their Medicare card. The co-payment is the amount the patient pays towards the cost of their PBS medicine. Many PBS medicines cost a lot more than the patient actually pays as a co-payment. From 1 January 2014, a general patient pays up to \$36.90 for PBS medicines or \$6.00 if they have a concession card. The Australian Government pays the remaining cost. The amount of co-payment is adjusted on 1 January each year in line with the Consumer Price Index.

The Closing the Gap PBS Co-Payment Measure is one of 14 measures under the Indigenous Chronic Disease Package. In rural and urban settings, the Measure improves access to PBS medicines for eligible Aboriginal and Torres Strait Islanders living with, or at risk of, chronic disease. The Measure lowers or removes the patient co-payment for PBS medicines, i.e. eligible general patients pay \$6.00 for each PBS prescription, while eligible concessional patients will receive their PBS medicines for free. Eligible Aboriginal and Torres Strait Islander patients are registered through a general practice participating in the Indigenous Health Incentive under the Practice Incentives Program or a non-remote Indigenous Health Service.

The Section 100 of the RAAHS Programme is administered under section 100 of the *National Health Act 1953*, and allows for the supply of PBS medicines to clients of eligible remote area Aboriginal Health Services at the time of medical consultation without the need for a normal prescription form, and without charge. The Programme aims to address

identified barriers experienced by Aboriginal and Torres Strait Islander peoples living in remote areas of Australia in accessing essential medicines through the PBS.

Payments and concessions provided to people in the Northern Territory compared to the rest of Australia is shown below.
