Question:

- a) How many people access Centrepay currently? Provide a breakdown by use of Centrepay by:
 - 1) payment type,
 - 2) age,
 - 3) gender,
 - 4) state and territory, and
 - 5) Indigenous status/non- Indigenous status.
- b) Provide a breakdown of the number of Indigenous Centrepay users by payment type, age, gender and state and territory.
- c) If possible, indicate how many Indigenous people in remote areas use Centrepay.
- d) Please provide an update to the Department of Human Services Independent Review of Centrepay:
- e) In the past 12 months, how many complaints have been lodged about Centrepay?
- f) How many businesses currently operate through Centrepay?
- g) In the last 12 months, how many businesses have had their contracts with Centrepay cancelled?

Answer:

To obtain answers in the limited time available, data reports as at different dates have been used. Consequently, the totals of different categorisations of Centrepay customers do not necessarily match, as the Centrepay customer base fluctuates over time.

Note that it is optional for customers to identify as an Indigenous Australian and this limitation should be considered in any application or use of this information.

- e) In the period 1 November 2014 to 31 October 2015, there were 127 complaints lodged with the Department about Centrepay service delivery.

- f) The number of Businesses (including government and non-government entities) receiving at least one Centrepay deduction in October 2015 was 13,118.
- g) In the period 1 November 2014 to 31 October 2015, 6,993 businesses had their Centrepay contracts cancelled. Of the cancellations, 6,247 occurred in September 2015, in the context of transition to the new Centrepay Policy and Terms.
