- **a**) Has this Action Plan been developed simultaneously with the Second Implementation Plan?
- **b**) What consultation has been undertaken with stakeholders in the development of the Action Plan?
- c) Were there any open consultations or were they by invite only? Did the Department engage directly with Indigenous people with disability, their families and carers?
- **d**) Please provide a list of all stakeholder consultations including dates, attendees and any costs incurred by the Department.
- e) Is there a budget allocation for this Action Plan?

- 5. 2014 Progress Report to the Council of Australian Governments notes that it includes feedback from people with disability, through their representative organisations, on the first phase of the strategy's implementation. Other than this has there been any formal evaluation or review of the first implementation plan?
- a) If so, was this conducted by the Department or by an external consultant?
- **b**) Is there a report on the evaluation/review? If so, could you please provide copies to the Committee?
- 6. When is the next Progress Report to the Council of Australian Governments due? Will these reports to COAG continue on as two yearly reports under the Second Implementation or will other reporting arrangements be established?
- 7. Has a communication strategy been developed raise awareness about the National Disability Strategy and Second Implementation Plan?
- a) Can you provide details of specific communication activities planned?
- **b)** Is there any funding associated with this work?

Answer:

- 1. The Second Implementation Plan draws on the National Disability Strategy's first biennial progress report to Council of Australian Governments (COAG), and the Disability Ministers' National Forum held in February 2015. It also reflects feedback received from extensive Australia-wide consultations with people with disability, their families and carers. There will be ongoing consultation with stakeholders on a range of implementation activities as they are progressed.
 - a) The draft Second Implementation Plan was provided to disability peak organisations for comment late in 2015, followed by a focus group in November 2015, and a revised draft for comment in April 2016. States and Territory Governments were also key partners in the development of the plan and had opportunity to engage with key stakeholders.
 - b) The Department engaged with People with Disability Australia, Women with Disability Australia, National Ethnic Disability Alliance, First Peoples Disability Network Australia, Children and Young People with Disability Australia, and National Disability Services.
 - c) The consultation process and dates are provided above. No specific funding was provided by the Department of Social Services (DSS).
- 2. Improving outcomes for Aboriginal and Torres Strait Islander people with disability has been identified as an area for increased national focus in the National Disability Strategy's Second Implementation Plan.
 - a) Yes.
 - b) A range of stakeholders have been engaged in the development of the Plan, including Aboriginal and Torres Strait Islander people with disability, their representative organisations, researchers and community organisations. These stakeholders were invited to attend a roundtable, held in November 2014, and several focus group meetings held during the first half of 2016.
 - c) Attendance at the roundtable and in the focus group meetings was by invitation. Participants were invited based on their expertise and experience as well as their lived experience of disability as an Aboriginal or Torres Strait Islander person with disability.
 - d) The roundtable on 21 November 2014 was facilitated by Mr Damian Griffis, Chief Executive Officer, First Peoples Disability Network Australia. The following stakeholders attended the meeting:
