Senator Urquhart asked:

The Answer to Question on Notice No. 13 from the 11 July 2014 public hearing of the Senate Select Committee on the NBN set out the brownfields premises NBN Co had passed with fibre on a weekly basis according to the "prior method" and the "revised method." Please provide this information from the week of 27 July 2014 until the most recent date for which data is available.

Answer:

The table below shows 'Premises Passed' as provided previously (prior method) and compares them with the 'revised method' as currently used in the weekly public figures. 'Premises Passed' (prior method) refers to premises that have the local, distribution and transit fibre in place and these elements of the network have been granted practical completion. A proportion of these are in Fibre Serving Area Modules (FSAMS) that have not been declared 'Ready for Service'.

'Ready for Service' refers to premises that are in an FSAM that has at least 90 per cent of its premises 'passed' and where the addresses have been loaded onto the service portal. The addresses are visible to Retails Service Providers (RSPs) and premises that are not Service Class Zero (SC0) can order a service.

On 1 April 2014 NBN Co began using the 'Ready for Service' metric in the weekly public reports, but kept calling this "Premises Passed" with a footnote explaining the amendment to the premises count.
