- 3. How many work points does ASQA have in all offices? ASQA has 270 work points at this time.
- 4. What is the allocation of office space per ASQA staff member? ASQA is a Commonwealth agency operating under the Financial Management Act. Allocation of office space for individual officers is based on the Australian Public Service according to level. The average allocation per ASQA officer is 26.5 square meters per head.
- 5. How many complaints about ASQA relate to timeframes about audits?
  Of the 133 complaints received by ASQA from establishment 1 July 2011 until 31 March 2013, only 9 or 6.7% complaints were about ASQA audit processes.

## 6. How many audits have been done in each state and territory?

Since 1 July 2011 until 31 March 2013 the total number of ASQA audits completed or currently underway is 2065. In addition another 606 audits have been identified but are not yet underway. The figures in Table 2 below provide a breakdown of the audit activity by each state/territory.

ASQA also has responsibility for regulating some Registered Training Organisations (RTOs) in Victoria and Western Australia
