- 1243. For the financial year to 26 October 2012, the details of all air travel by APRA officers is as follows:

- 1244. APRA utilises the Government's centralised airline booking service to secure 'best fare of the day'. This may or may not incorporate direct routes when travelling and is monitored by monthly reports from the provider.
