- 1324. The ACCC's expenditure on legal services from the Australian Government Solicitor for the 2011-12 financial year was \$14,176,417. This is comprised of expenditure on Professional Service Fees in the amount of \$11,049,575 and Legal Counsel Fees of \$3,126,842.
- 1325. The ACCC's expenditure on legal services from private firms for the 2011-12 financial year was \$12,065,442. This is comprised of expenditure on Professional Service Fees in the amount of \$8,916,833 and Legal Counsel Fees of \$3,148,609.

- 1328. The ACCC's expenditure on legal services from the Australian Government Solicitor for the financial year to date (to 31 October 2012) was \$5,418,767 (GST exclusive). This is comprised of expenditure on Professional Service Fees in the amount of \$4,289,265 and Legal Counsel Fees in the amount of \$1,129,502.
